3.4 Setting Up a Coordination Body At the National Level

The promotion of national strategy involves the interests and relationships between different departments and regions. It is necessary to fully coordinate, so it is necessary to set up a corresponding coordination structure to ensure its long-term and stable development. It is necessary to build professional, scientific and independent national institutions, reduce problems due to conflicts of ideas and interests, and fully reconcile the relationship between the central and local governments to avoid protectionism in the free trade zone.
