Classes are more clear and understandable to students, but the staff of the school and department departments mostly lacks understanding of the students they are reviewing. Therefore, in many cases, it is not possible to conduct a comprehensive review. Therefore, some individuals have "black-box" operations, resulting in Scholarships and the "three students", "excellent graduates" and other series of honors selection process and the credibility and fairness of the results are greatly reduced. If students appear to reflect such unfair events to the university leadership, it will not be conducive to the development of a harmonious and stable order in colleges and universities.
