For example, environmental surveys and environmental publicity can be carried out on special occasions such as World Environment Day and World Earth Day, so that students can understand whether the surrounding environment is good and improve the group of students. The external ethical level of citizenship. Unscheduled activities are mainly difficult to clearly arrange in advance, for sudden environmental events, environmental news or activities arranged to assist a social environment. Environmental moral education should be a lifelong education. Beginning with the preschool education stage, all formal education and non-formal education are carried out continuously, with people's life. Lifelong education covers both the characteristics of comprehensiveness and sustainability. As a kind of new-oriented education for environmental issues, environmental moral education, as an organic part of environmental education, can obviously meet the connotation and characteristics of lifelong education. The superficial symptom of environmental problems is ecological imbalance, and the root cause is the result of hundreds of years of industrial civilization. This evil is caused by the continuous destruction of human beings, so environmental ethics persistence is to continuously correct human errors. As a new content of moral education, environmental moral education has a moral outlook. Environmental moral education educates people to form a moral outlook, a harmonious economic outlook and aesthetics that protect and improve the environment. Because environmental morality itself is moral, how to cultivate the generation of environmental morality is the core issue of environmental moral education in moral education.
