


Figure 1 The method and process of critical analysis of Marxist-Leninist political economy in this paper

In carrying out the above critical analysis, the analysis method used in this paper is shown in the flowchart of Fig. 1 below.




Figure 2: Five levels of discussion on the development trend of the object of Marxist-Leninist political economy
