# A Study of Civil and Commercial Law Based on Moral Education

In addition, the commercial law started late, and the number of researchers is scarce. The system of commercial law is not perfect enough, so the teaching content can only be selected as a mature professor. Therefore, there are fewer teachers in business law, less comprehensive research fields, and students can not learn the essence of business law.

# 3.2 Backward teaching methods and modes

At present, most colleges and universities are limited to the traditional mode of teaching. Teachers give lectures in class and students take notes below. The result is that the teachers'teaching tasks are completed and the students' knowledge is very little. In the new era, the demand for talents is constantly increasing. Talents of high-quality and compound application are repeatedly mentioned. However, the current teaching methods and models are backward, students learn less knowledge, and they are unable to cultivate students'ability to innovate and start businesses. Teachers can not wait for feedback on the content of teaching, nor update their own teaching methods. ### 3.3 There are deviations in teaching concepts

Having a good teaching concept can help colleges and universities focus on the cultivation of talents and meet the standards of social talents. At present, there are some deviations in the teaching concepts of most colleges and universities, which pay too much attention to the theoretical curriculum guidance of students and neglect the practical requirements of students. In the course of teaching, teachers also tend to single theoretical teaching, and students only receive basic boring theoretical knowledge. At present, the demand of society for talents is applied and compound practical talents. The theoretical knowledge talents can not meet the current social progress requirements.

# 3.4 The integration of moral education and civil and commercial law is not high

Moral education focuses on cultivating students' basic moral quality, cultivating moral feelings, establishing moral beliefs and cultivating moral habits. University is the best place for students to learn knowledge, and it is also the best time for students to cultivate their outlook on life and values. Students' legal knowledge content and consciousness are poorly trained, and moral education is neglected, which leads to the rising rate of students' crime. Not only that, teachers in the teaching process, the inertia of teaching students textbook content, but neglected the cultivation of students' moral quality, as well as examples of proof. Students do not understand knowledge, and there is no other content of learning, not only useless to society, but also enhance the harm to society. It emphasizes the study of students only, but not the moral content. As a result, people without morality will become more knowledgeable and do more evil. The more vulnerable they are to the loopholes of the law, the more harmful they will be to society.

# 4. Teaching Reform of Civil and Commercial Law under Moral Education

# 4.1 Speeding up the construction of high quality teachers team

Colleges and universities should speed up the construction of high-quality teachers team to ensure the adequacy of teachers. First of all, colleges and universities should constantly cultivate high-quality knowledge talents with ethical and moral literacy. To ensure that students become teachers in the latter stage after better guidance for students, to create a good teaching environment for students. Secondly, schools should train and train teachers'teams strictly. Schools should often organize relevant teacher course competitions to promote the quality of teachers'teaching and ensure high-quality teaching. Moreover, schools should regularly organize teachers to study outside, learn the teaching methods of other excellent teachers, and learn the essence of legal professionals

at other levels. Thirdly, universities should also set up incentive mechanism to give material or spiritual incentives to excellent teachers who students like, so as to improve teachers'teaching enthusiasm.

# 4.2 Innovative teaching methods and models

The traditional teaching methods are mostly based on teachers'teaching and supplemented by students' listening. In view of the traditional teaching mode, colleges and universities should constantly innovate and reform the current education mode, to achieve student-led, teachers as the main body. Firstly, colleges and universities should actively advocate students'personality requirements. Secondly, teachers should improve the efficiency of classroom teaching. Third, increase opportunities for practice. Teachers should not only cite more cases, but also take students to practice law in person. ### 4.3 Reforming the teaching idea of civil and commercial law with the idea of moral education

More than half of moral education achieves multi-sensory experience by means of practice, examples, or scenario simulation, so that learners can more vividly understand the content of moral knowledge. In view of this, colleges and universities can change their traditional teaching concepts and incorporate more updated teaching concepts. From teacher professor as the main body to teacher professor as the auxiliary, students' immersion experience as the main body, so that students can better learn what they want to learn. As well as to increase students to practice activities, and encourage students to participate in relevant competitions. Students practice more, naturally they will have a better understanding of what they have learned, and help them not understand the knowledge can better answer. With more students participating in relevant competitions, students not only know where their knowledge weaknesses are, but also teachers can provide better answers. Law is a major subject. Student learning can not only promote the perfection of national law, but also help the prosperity and development of the country.

# 4.4 Cooperative innovation of moral education and civil and commercial law

Moral education is a good promotion to the development of students, helping students avoid being poisoned by violations of social laws. Therefore, colleges and universities require teachers to advocate moral knowledge when teaching civil and commercial law. In the course of teaching, teachers can put the idea of moral education into civil and commercial law through case study. Students also absorb the idea of moral education when they study knowledge.
