The grassroots league organization is not only the main front of the life of the league members and youth organizations, but also assumes responsibilities such as ideological guidance, quality improvement, innovation and entrepreneurship, and career development. Whether in the understanding of workers or students, there is still a "Chu River and Han boundary" at the boundary between the class league branch and the class, the integration is not high, there is less communication, and there is even "the class league branch and the class committee". Everyone's self-sweeping of the snow in front of the door"[2]. The league members pay attention to their academic performance and "second classroom" results, show strong utilitarianism, lack interest in the daily affairs and activities of the league branch, and mostly focus on completing tasks, get by without having deep thinking. Many college youth league branches are not very clear about their missions and responsibilities, lack the sense of responsibility, and do not help enough for youth league members to fully grow and become talents. The students' ignorance, lack of understanding, and carelessness in the construction of class and group integration have also created invisible obstacles to the smooth implementation of class and group integration. He was busy with campus activities outside of his studies. He despised the position and views of the League branch. He stayed out of the League branch for a long time because of the small platform of the League branch. The Youth League branch's awareness of actively serving youth is not strong, and the form of serving youth is rigid, resulting in the youth's low enthusiasm for participating in the Youth League branch activities and a weak sense of belonging to the league organization [3].

2.2. The powers and responsibilities of the Youth League branch and the class committee are unclear.

The class league branch and the class committee, as the two institutions of the same organization, should have clear powers and responsibilities, and work together to efficiently complete the service work for the class and the league branch. In the construction of the integrated operation mechanism of the group and the group, the contributions of the group branch and the group committee play a vital role in the construction of the group and group integration. They should give full play to their respective strengths and correspond to corresponding responsibilities. The corresponding matching effect. In the process of specific work, the emphasis was placed on transactional work, ignoring the student cadre's own student status, lacking experience, and lacking systematic guidance and training,

especially the education and guidance of league branch cadres. When some instructors and class teachers arrange their work, they do not distinguish between the daily work of the class and the work of the league branch, and the task of the group is assigned to the class leader for implementation. As a result, some league branches have replaced the league branch meeting with the class meeting and replaced the group day with class activities. Activities and other phenomena [5]. The construction of the league branch of the class is still weak, the ideological leadership is not strong, the function is lacking, the attraction to the league members and the masses of students is not enough, the organization consciousness of the league members is weakened, the recognition of the league branch in the class is not high, and the students still mainly approve the class unit. The League cadres of the Youth League Committee of colleges and departments are the main force guiding the work of the League branch, but they are mostly part-time and the number of cadres is small. Faced with many League branches, they have limited energy to carry out work and are not able to guide the team work.

2.3. The competence and quality of the integrated managers of universities needs to be improved.

In terms of quality development and cultural and sports activities, combined with the actual situation of each branch of the grade, use the day without school and no self-study days to carry out various cultural and sports activities and quality development activities. Counselors are the main undertakers, implementers and managers of the construction of the integrated operation mechanism of the group and the group and the implementation of the integrated construction work of the group and the group. Participate in the process of student development guidance, create a benign social support system for student development, so that the problems encountered by students in the development process can be effectively solved.

3. Implementation Strategies of the Operational Mechanism of the Integration of Class and Group in Universities

3.1. Persist in the development of new concepts and expand the construction pattern of the integration of universities

Universities should realize the integrated operation mechanism of class and group. First of all, it is necessary to build a linkage mechanism for class and group management. While promoting the management of class committees, universities must also mobilize the initiative of the Communist Youth League members.
