In the recapitulation, both themes reappear in G minor, with the first theme more agitated and the second more sorrowful and melodious.
Second Movement	Sonata form	6/8 time	E-flat major	Gentle and Lyrical: Strikes a sharp contrast with the first movement, shifting from a hasty pace to a gentle one, and from G minor to E-flat major. The movement consists of two relatively contrasting themes that are calm, bright, lyrical, and complementary to each other, creating a warm and melodious atmosphere.
Third Movement	Minuet (Menuetto), Allegro	3/4 time	G minor	Lively and Cheerful, with a Sense of Solemnity: Although named a minuet, it resembles a solemn march. The theme has a syncopated rhythm, and the melody is built on the decomposition of G minor chords, presenting a solemn and confident image. The middle section shifts to G major, and the melody becomes bright and warm, making it the brightest moment in the entire symphony.
Fourth Movement	Sonata form	2/2 time	G minor	Intense and Dynamic: Begins with a fast and powerful rhythm, and the melody is full of contrast. The first theme is played softly by the strings in the first half, and then shifts to a majestic full orchestra in the second half. The second theme is played in B-flat major, with a delicate and bright melody. The development section frequently modulates, and the fugal section brings a sense of solemnity and instability in tonality, making the music full of dramatic tension.

Notes: Mozart's "Symphony No. 40" was completed in 1788 and is one of his most well-known symphonies. The entire symphony is passionate and full of emotional musical ideas, reflecting Mozart's deep thoughts on life, love, and fate. The symphony adopts the traditional four-movement structure, with each movement having its unique musical characteristics and expression.

When enjoying "Symphony No.40", the musical elements in the music touched the hearts of the audience like magic, which triggered endless imagination and association. Melody, Mozart drew a vivid picture of music with smooth and expressive lines. Whether it is the passionate and solemn theme of the first movement or the gentle melody of the second movement, people seem to be in different emotional worlds. Rhythm, he skillfully used a variety of rhythms, making the music sometimes passionate and unrestrained, and sometimes quiet and restrained, leading the audience's emotional ups and downs. In harmony, Mozart's application of harmony is rigorous and innovative, which adds rich colors and layers to the music. Take a specific passage of the first movement as an example: when the passionate theme melody rings, it seems that a heroic picture emerges in the audience's mind; With the advancement of music,

the melody gradually becomes soft and lyrical, and the audience's imagination changes accordingly, as shown in Table 3.
