Jingzhou for example, 2017 Jingzhou International Marathon full registration fee is 120 yuan per person, half of the registration fee is 80 yuan per person, mini marathon registration fee is 50 yuan per person. Table 1 shows that Jingzhou is more expensive than other cities in China, but Jingzhou is only one of many cities. The Organizing Committee shall consider reducing the registration fees and formulating preferential policies to establish reasonable fees.
