The Rule of Law for Business and the Construction of a High-Quality Business Environment

The legalization of the business environment plays a pivotal role in the modernization of the national governance system and governance capabilities; a high-quality business environment requires that the system and mechanism have the basic characteristics of stability, fairness, transparency, and predictability, and it is also inseparable from the guidance, promotion, regulation and guarantee of the "biggest common factor" in the construction and operation of the rule of law, the two are highly compatible with each other in the pursuit of value and the path of realization, and they promote mutual progress. While various economies are competing to optimize the business environment with the rule of law (thinking and methods), the effectiveness of Gein rule of law reform can be confirmed in the dynamic changes in the ranking of business environment convenience. It is said that the ranking changes caused by the thousands of "establishment, reform, and abolition" of the rule of law practice not only reflect the correlation between the "effective and easy to follow and understand" legal system and the rapid and high-quality economic development, but also added a powerful footnote of legal positivism to the major thesis that "the rule of law is the best business environment" put forward by General Secretary Xi Jinping. In the meantime, China's overall ranking in the 2020 Business Report has risen to 31st in the world which is benefited from the gradual implementation of the major deployment for comprehensively advancing the rule of law, and the rule of law has undoubtedly played a key role in strengthening the foundation, stabilizing expectations, and benefiting the long-term in the construction of the business environment.

2. The Thinking and Practice Path of Business Rule of Law

Under the background that the scope of business evaluation is gradually shrinking, the "rule of business law" should take the empirical and data-based "inspection" and "verification" results of legal norms as the content fulcrum for constructing a legalized business environment [2], let our eyes go back and forth between the "(rule of law practice) survey data" and the current business law texts, and distinguish the "laws as they should" and the "laws of reality" exist in the system "gaps", adapt the systematic legal system and the rule of law practice to provide a method for the construction of a high-quality business environment guided by freedom, fairness, safety and order in the basis of the construction methodology of the two phases of "nuclear" and "reform".

3. Evaluation-Experience Interpretation of "Inspection" and "Inspection" in Business Practice

In an enterprise-centric context, the business practice evaluation report benefits from the "brand effect" and displays a lot of useful empirical information: distinguishing the degree of difficulty in doing business in a region; promoting economic reforms to carry out business operations; explaining how business reform can optimize business operations (reasons and quality of reform measures), etc. For example, the analysis of empirical information on regions and reform measures in the "Global Business Environment Report" clarifies the relationship between a high-quality business environment and greater development space; that is, under a better business system environment, entrepreneurs will spend longer time in economic activities, and the proportion of time spent on productive daily operation and management will be higher, and the proportion of time spent on non-productive affairs will correspondingly decrease; in the environment of a high-quality business system, property rights protection, judicial justice, contract fulfillment and other aspects are usually more effective, and the efforts of entrepreneurs will be more allocated to productive areas.

In this regard, General Secretary Xi Jinping's major thesis that "the rule of law is the best business environment" objectively clarifies and intuitively points out the direction of the optimization of the business environment; it also highlights the significance and advantages of the "rule of law" for the business environment: the rule of law is the only way to achieve a stable, fair, transparent and predictable business environment. In fact, many reforms (such as the separation of licenses) are all existing rules, the World Bank continues to iterate and update the convenience of business environment rankings, which aims to promote the reform of the rule of law in various economies to optimize the business environment. Through the practice of the rule of law of "establishment, reform, abolition", business evaluation has successfully promoted more than 3,500 reforms in 10 business regulatory fields, institutional reform under the rule of law has improved the overall level of the global business environment; especially in the evaluation index of starting a business, 178 economies have implemented 722 reforms since 2003-2004 [4], these legal practices which reduce or eliminate barriers to business access have reduced the time for registered enterprises (global average) from 47 days in 2006 to In the 20 days in 2018, China strives to further reduce the time from 8.9 days in 2018 to 4 days or less by the end of 2020. The construction of a legalized business environment greatly liberates and improves the productivity and competitiveness of enterprises, intuitively demonstrates the simple and abstract relationship between good law and good governance and good economic performance, and presents the factual materials that the construction of the rule of law and the optimization of business practices promote each other's mutual advancement for the proposition of "system is essential".

4. Shaping-China's Approach to the Construction of a Legalized Business Environment

The World Bank's business report has been changing year by year, during which there have been many changes and improvements in evaluation methods and evaluation indicators; however, the "initial intention" of its rule of law evaluation methodology has remained unchanged: the legal system that concerns (promotes or hinders) business activities has always been improved "inquire" and "inspect", based on empirical data to evaluate what kind of business regulatory legal reforms are effective, under what circumstances, and why [5]. However, the legal provisions that should be expected are not the same as actual regulatory effects, the separation of central and local powers makes central policies not necessarily effective at local levels, different actions in the institutional space such as administrative coordination, judicial discretion, and pilot innovation, make the business environment a new field for local governments to compete. The business competition of different governments actually echoes the shortcomings of the World Bank's business evaluation system mentioned in the previous article-it cannot meet the needs of the overall evaluation of the rule of business with a vast territory and differences. Therefore, how to use the "rule of law expertise" methodology of business evaluation to correct the current situation of the "big rule of law" evaluation with mixed elements in the domain is an extremely test of the wisdom of methodology [6]. More importantly, "legal norms are not only a legally effective regulation, but also specific social relations, social processes, and behavior patterns; however, regulated by the law, it is only the multiple presented by the latter-ears."

"Law is the most important tool for governing the country, and good law is the prerequisite for good governance," it is necessary to "use good laws to promote development and ensure good governance", and "put the core values of socialism throughout the legislative, law enforcement, judicial, and law-abiding links to make the socialist rule of law and good governance". The shaping

of the business environment under the rule of law should always be guided by the scientific connotation of Xi Jinping's new ideas, new ideas, and new strategies for comprehensively governing the country according to law, recognize the experience of business practice evaluation, lay the foundation for legal methodological thinking, and promote the practice of business rule of law and the rule of law The inspection, introspection and construction of the system provide complete and proper protection for the entire life cycle of business activities of the enterprise, which will lead to the establishment of a macroscopic rule of law in China.

Thirdly, "the decisive role of the market [8]" is the corrective path for the construction of a legalized business environment. The logical starting point for the legalization of the business environment is the market economy, and the key is to establish the concept of legal governance in the market economy; the traditional "national coordination" idea should be changed to make it clear that the government's regulation of the market is legal governance rather than power governance; government It is only the implementer of legal norms rather than the direct parties to economic legal relations; the government only needs to adjust the economic structure and interest relations, and the market plays a leading role in resource allocation.

Finally, the improvement of "systematic life cycle [9]" is the development direction of the rule of law business environment. To construct a legalized business environment, systemic system optimization must be based on the "life cycle" of the enterprise: "multiple integration" in a single business, collaborative management to improve efficiency; information sharing in the process, reducing the "system cost" of enterprise operation; realize the optimization of the rule of law system based on the concept of business environment optimization.

The rule of law and the business environment are intrinsically connected and internally compatible. The governance rules that companies follow are the basic material for the construction of the rule of law, and the framework of the rule of law provides institutional guarantees for business operations. On the basis of the major thesis that "the rule of law is the best business environment", only a deep understanding of Xi Jinping's new ideas, new thoughts, and new strategies for comprehensively governing the country according to law, and stronger legal measures to optimize the business environment, can continue to release new economic growth in China System dividend. To implement the "new ideas, new thoughts, and new strategies", we must adhere to the rule of law under the leadership of the party, and fundamentally deal with the dialectical relationship between the party and the construction of the rule of law; the system "protection net" established by the rule of law should equally protect the property rights and legitimate rights and interests of various market entities in accordance with the law; regulate the boundary between the government and the market under the rule of law, respect the laws of market economy, let the market play a decisive role in the allocation of resources [10], adjust the interest relationships of various market entities; improve the system, strengthen supervision, and establish a unified, open, and orderly competitive market system within the framework of the rule of law, and provide a "full coverage" system guarantee for business operations with a fair and just competitive environment.
