The quality requirements and evaluation standards for personnel training ensure that the quality management system is continuously improved and improved to maintain and ensure the normal operation of the education quality assurance system.

1.3. Quality Assurance Monitoring System

The education quality assurance monitoring system is a comprehensive and effective observation, supervision and control of various factors related to the quality of education. School leaders, academic affairs departments, supervision teams, departments, experts, professors, and students should form an independent department. They should be responsible for observing and supervising all aspects and elements of education quality.

In accordance with the requirements of educational quality standards, the education quality assurance system within the school, the management responsibilities and authorities of each department, and the code of conduct are determined in the form of organization and system. Standardize the standards and procedures for the quality of education, and stop behaviors that are contrary to the quality of education.
- (3) Conduct supervision and supervision under the direct leadership of the school leadership and the Academic Affairs Office. Effectively monitor and supervise all aspects of education quality, such as classroom teaching, practical training and practice, professional construction, curriculum, talent training process, academic style, and quality and cultural environment.

3..3. Establish a Social and Market-based Regulation and Constraint on Internal Education Quality Assurance Mechanisms

In the process of vigorously developing vocational education in the country, the introduction of social and market mechanisms into the quality assurance process of vocational education is an effective mechanism and guarantee measure for improving the quality of education in higher vocational colleges. It is also a construction mechanism for the operation quality guarantee system of higher vocational colleges. important content. Therefore, in the process of improving the quality of personnel training, higher vocational colleges should strengthen cooperation with the society, establish a stable school-enterprise cooperation relationship, form professional, professional and innovative talent training, and then let enterprises evaluate student training. On the other hand, it is necessary to strengthen contact with the market, adjust the professional settings and curriculum construction according to the needs and mechanisms of the market, so as to better cultivate talents who meet the needs of the society. At the same time, according to the characteristics of running higher education institutions and the goal of talent training, we should actively learn from and absorb the elements of corporate culture. We must explore and study the integration of corporate culture into the construction of "quality culture" in schools and establish a core of "quality culture".
